2013 Business Meeting Dakota Chapter American Fisheries Society February 27, 2013

President Mike Olson called the meeting to order at 3:45 PM.

President's Report (Mike Olson):

The agenda for the business meeting has been published in the meeting materials. The Dakota Chapter Report was sent to the NCD for their annual briefing book. I was snowed out of the Midwest Fish and Wildlife Meetings. An invitation to the annual meeting was sent to Director Steinwand who kicked off our gathering this morning. I worked with Rick Nelson and Tyler Berger on the budget for the annual meeting and we are able to cover the costs associated with our annual meeting. We agreed to kick in an additional Sauger Scholarship to bring the total to 5 this year. We're pleased that Gwen White. Past-President of NCD could be with us this year and she will share her comments on the NCD during newbusiness.

Vice President's Report (Rick Nelson):

I worked with Mike and Tyler on meeting preparations. I'm Really pleased with the number of paper and poster submissions as well as the speakers who made it to the meeting from Minnesota, Indiana and Montana. The Comfort Inn staff has been extremely helpful to our cause and we encourage future excom members to consider coming back to Bismarck and working with them.

Secretary/Treasurer Report (Tyler Berger):

Money was transferred from or spent directly from the Edward Jones account to cover meeting costs, photo contest gift cards, printing of programs, and other misc. 2013 Fall Excomm Meeting Dakota Chapter American Fisheries Society August 29, 2013

President Mike Olson called the meeting (conference call) to order at 9:00 am. Ex Com members present in attendance were Mike Olson, Chris Longhenry, Rick Nelson, Tyler Berger, Dan Dembkowski, Andrew Carlson. Also in attendance were Kurt Eversman, Natalie Scheibel and Mark Fincel

Presidents Report (Mike Olson).

A few items of note since our annual meeting in February. I worked with Tyler and national office to get award plaques made and sent out to the paper/poster winners from the annual meeting. I was contacted by a member of the NCD regarding the Invasive Species Screening Act to see if the Chapter might endorse the draft legislation - I shared the legislation with members of the environmental concerns committee and subsequently let them know we supported it. We sent letters to the Congressional offices in both states related to a recent effort by the Congress members from the state of Missouri to remove "Fish And Wildlife" from the list of Congressionally Authorized Purposes under which the Corps of Engineers operates the Missouri River. As a result of our letter, we were asked to meet with North Dakota Congressman Cramer about Missouri River Issues. Al Sapa from the ND Chapter of The Wildlife Society and I met

with the Congressman and discussed our concerns with the proposed legislation

Vice Presidents Report (Rick Nelson).

Final numbers from the 2013 annual meeting were great. Rick had discussions with new AFS Executive Director, Doug Austin, about possibly attending our 2014 annual meeting in Chamberlin. Doug mentioned he started in SD and looked forward to returning to his roots.

Secretary/Treasurer Report (Tyler Berger).

Account balances as of 8/28/13: U.S. Bank checking account \$7,613.56, and the Edward Jones account \$6,500.05. Tyler is working to establish a new checking account (for the time being) as the home for any contributions to the Robert Klumb Scholarship fund.

President Elect Report (Dan Dembkowski).

South Dakota Game, Fish and Parks Update

The Fisheries and Aquatics Resources program created a draft strategic plan during 2013 as part of their adaptive management system and the plan is currently out for public review. The plan includes a statewide component, covering aspects of the program common to all areas of the state, and Fisheries Management Area plans for the Black Hills, West River, Missouri River, and East River areas of the state. A majority of the GFP fisheries staff, GFP Wildlife Division GIS staff, and a few SDSU fisheries professors contributed to the various plan components. These plans outline major or common management issues, management goals and objectives, and strategies to address issues so objectives can be met. More detailed plans for specific water types or individual waters will be generated as well and these plans are identified as strategies in the current statewide or management area plans.

A key strategy of the Black Hills plan is to conduct a study of Black Hills anglers opinions and preferences for the management of stream fisheries and small impoundment fisheries in the Black Hills. Contact information is currently being gathered from anglers fishing in the Black Hills and this information will be used as the data set for a detailed angler survey to be conducted beginning next September.

Staff Update

A few staff changes have occurred since the May 2013 Dakota AFS newsletter was published. Steve LaBay, our habitat and access biologist in Webster, resigned and returned to school at SDSU to pursue a civil engineering degree. In late December, Rhett Russell will be joining the Fisheries and Aquatics Resources program to fill the position vacated by Steve. Rhett has a Parks Management degree from SDSU and has been working as a park manager and public water access manager in northeast South Dakota for the GF&P Parks Division. He has partnered with the Wildlife Division's fisheries program on many access projects. In addition to fishing access work, Rhett will be continuing efforts to establish shoreline restoration projects on eastern South Dakota lakes, working with watershed projects, and handling permitting responsibilities for shoreline modification and aquatic plant herbicide application.

Matt Wipf, the hatchery assistant manager at McNenny State Fish Hatchery in Spearfish, resigned to return to Montana and work as a fish culturalist at Giant Springs State Fish Hatchery in Great Falls. The vacancy at McNenny is currently in the process of being filled.

North Dakota Game and Fish Department Update

Statewide Outlook

Before I quickly recap 2013, I'd like to take a step back and note what was observed in 2012 (due to delays in paper licensing, the ND Game and Fish cannot finalize records for the previous year's fishing season until the following June). 2012 was record breaking on all fronts. More than 218,000 fishing licenses were sold last year, 20 percent higher than the previous record set in 1982. A total of 159,500 resident fishing licenses were sold, also breaking the record set 30 years ago. In addition, nearly 59,000 nonresident fishing licenses were purchased, easily surpassing the previous high set two years ago. In terms of actual individuals participating in fishing, 2012-13 was again record-setting with more than 200,000 active anglers and about 2 million days of fishing. Both open water and ice fishing activity experienced substantial increases. Lake Sakakawea, Devils Lake and Lake Oahe/Missouri River remained the top three fisheries in the state. Years of rising water, a record number of fishing lakes and aggressive fish management in North Dakota have helped produce record fishing license sales.

Now for 2013 ... by all accounts fishing has been better than 2012 throughout the vast majority of the state. Of the big three, Sakakawea and Devils Lake were again good to outstanding, while Lake Oahe/Missouri River was the only 'downer' (again related to the 2011 flood and loss of the rainbow smelt forage base). What was really first-rate this past summer was fishing on our small lakes. For example, we received countless reports from anglers, game wardens, etc. of 15-20 boat trailers at many of these lakes on any weekday in August - obviously the fish were biting. The number of fishing waters in North Dakota are at an all-time high and as long as we don't enter into a significant drought, we should be able to maintain this level at least for the next few years.

Regarding a couple of 'business' related matters, we again had exceptional walleye fingerling production from the Garrison Dam (9.7 million) and Valley City (1.3 million) national fish hatcheries that

resulted in a record of approximately 11 million walleye fingerlings stocked into state waters. This should bode well for the future. Also related to these hatcheries, there has been a lot of rumor and some discussion regarding the federal commitment to the national hatchery system. While it is true there is a trend of less 'Fish' in the US Fish and Wildlife Service nationally, it is our understanding that the North Dakota hatcheries should be able to continue to operate, at least similarly, as in the past.

The new 2014-2016 fishing proclamation will see very little change. It should be noted that the Department has decided to wait at least a year before developing a lottery to issue tags for the paddlefish snagging season. After full review of the 2013 paddlefish season, and considering ongoing research on the paddlefish population, biologists have determined that a lottery is not necessary in 2014.

Department staff spend a good amount of time again addressing various aspects of Aquatic Nuisance Species (ANS) prevention and control. Fortunately, despite a lot of 'looking', North Dakota only had one new infestation of an ANS in one lake. Staff also spent a record amount of time conducting fish sampling on a record number of lakes, developing new and maintaining a record of old boating access sites, stocking a record number of lakes, and addressing fishing lakes water quality issues throughout the state.

If Mother Nature cooperates, the winter will provide phenomenal fishing opportunities. It's always a good time to get out and wet a line!!! Happy angling!

Esocid Technical Committee Report Update

South Dakota

Blue Dog State Fish Hatchery received 1,100 muskellunge fingerlings through lowa from Indiana. These fish were held throughout the summer and were then stocked into Lake Sinai in the fall.

Northern pike populations remain strong across eastern South Dakota. Northern pike sampling catch rates for 2013 can be viewed at http://gfp.sd.gov/fishing-boating/tacklebox/lake-surveys/default.aspx.

Darkhouse spearing for northern pike became legal last winter for all inland waters. Participation appears to be good and no significant issues have come forward.

Pactola Reservoir Northern Pike Assessment

South Dakota State University Graduate Student Natalie Scheibel under the direction of Steve Chipps recently completed an assessment of northern pike in Pactola Reservoir, located in the Black Hills of South Dakota. The population resulted from an illegal introduction into a water traditionally managed as a trout fishery. The objectives of this study were to: (1) determine age and growth of Northern Pike in Pactola Reservoir, (2) assess growth differences among Northern Pike that consume varying amounts of Rainbow Trout, (3) and compare Pactola Reservoir Northern Pike growth rates to growth rates of other Northern Pike populations. Northern Pike were collected in 2012 and 2013. Cleithra were collected from all Northern Pike and used to calculate mean lengths-at-age. Von Bertalanffy growth models were developed for the overall northern pike population, as well as for males and females separately. Northern Pike larger than 600 mm tended to consume primarily Rainbow Trout (56%) and had the highest relative weights within the population (P < 0.05). Females grew faster and larger than males, and they also tended to live longer. The Pactola Reservoir Northern Pike exhibited slower growth than the other populations it was compared to, but had longer lifespans, with some individuals living to at least to age-12. Pactola Reservoir Northern Pike reached comparable lengths, equivocal to or greater than those from faster growing populations. Cooler water temperatures and lake morphology may slow growth but allow Northern Pike to have longer lifespans. However, the combination of abundant resource availability and water clarity of Pactola Reservoir allow northern pike to efficiently prey upon rainbow trout. Once Rainbow Trout become the main

dietary item for these northern pike growth and condition were improved.

Muskellunge vs. Standard Fyke Net Evaluation

Since the initial introduction of muskellunge into South Dakota, these fish have proven difficult to sample with SDGFP standard fish sampling gears (e.g., fyke nets, gill nets and electrofishing). Sampling of muskellunge is imperative to gauging the success of stockings and to collecting information on various metrics (e.g., growth, fish condition, relative abundance). The Minnesota Department of Natural Resources (DNR) has recommended the use of large fyke nets (5 x 6 ft. frames, 5 ft. diameter hoops, 100 ft. lead, double throated and 0.75 in. knotless mesh) set at specific locations during the spring to collect muskellunge. The SDGFP is interested in adopting the Minnesota DNR methodology for sampling muskellunge, but first must determine if it will work in South Dakota waters.

During the 2013 spring, the SDGFP compared the catches of muskellunge collected in the standard SDGFP fyke nets (3 x 5 ft. frames, 3 ft. diameter hoops, 50 ft. lead, single throated and 0.75 in. knotted mesh) and the Minnesota DNR muskellunge fyke nets. Three lakes (Amsden Dam, Lvnn Lake and West 81) were included in the 2013 evaluation. At each lake, 10 subjective sites were selected for net placement and five standard fyke nets and five muskellunge fyke nets were randomly placed at the 10 sites and checked daily. Sampling occurred at or shortly after ice-out on each water and continued for a minimum of five nights. All collected muskellunge were implanted with a passive integrated transponder (PIT) tag for future identification.

Results in 2013 showed that more muskellunge were collected in the larger fyke nets. However, because of the limited number of nets used the sample size remained small. In 2014, the comparison study will be repeated with an increased number of nets (10 standard and 10 muskellunge fyke nets).

Robert A. Klumb Memorial Scholarship

Call for Applications

The Robert Klumb Memorial Scholarship was established in memory of Dr. Rob Klumb, former Project Leader for the US Fish & Wildlife Service and Adjunct Associate Professor at South Dakota State University. The award provides financial assistance for deserving students to attend the annual meeting of the Dakota

Chapter of the American Fisheries Society (AFS).



Rob Klumb was an exceptional colleague and friend whose life tragically ended on July 8, 2013 in Pickstown, South Dakota. A Wisconsin native, Rob received his B.S. from the University of Wisconsin-Milwaukee in 1990 and his M.S. degree from the University of Wisconsin-Stevens Point in 1997. Rob joined the Department of Natural Resources at Cornell University in 1997 where he studied bioenergetics and near-shore habitat use by larval and juvenile alewife at the Cornell Biological Field Station, earning his Ph.D. in 2003. In 2002, Rob joined the U.S. Fish and Wildlife Service in Pierre, South Dakota as a Fisheries Research Biologist and was promoted to Project Leader of the Great Plains Fish and Wildlife Conservation Office in 2009.

Rob was a talented biologist who led a variety of research projects on fishes of the Missouri River. In addition to his Federal job duties, Rob also served as an Adjunct Associate Professor at South Dakota State University, where he played a fundamental role in coordinating federal research needs with student education.

Colorful, energetic and always positive, Rob was inspirational to students and colleagues. He always took the time to avail himself to other people to help them in their professional and personal

endeavors. As a mentor, he led by example, and his hands-on approach earned him a large and loyal group of colleagues. His legacy will live on in the example he set for students and future professionals.

Rob's passion for science, politics and Milwaukee-made beer ran deep and wide. His inclusiveness and openmindedness extended to both his work and his social life, and he will be remembered for the enthusiasm he exhibited in his approach to both. From the technicians that worked under his guidance to the students he mentored to the colleagues he left behind, his loss leaves a big void in the fisheries community. The Robert A. Klumb Memorial Award was established in memory of Robert Klumb, a life member of the Dakota Chapter of the American Fisheries Society. The scholarship recognizes outstanding student contributions in fisheries science. Donations can be made to: Dakota AFS -Klumb Fund, USGS South Dakota Coop Unit, NPBL 2140B, South Dakota State University, Brookings SD 57007.

Any student who is active in fisheries science is eligible to apply. Awardees are chosen by a committee of the Dakota Chapter AFS. Selection is based on academic qualifications, professional service, and a short essay describing the

applicant's philosophical outlook on fisheries science. Travel and (or) research support of \$200 per award will be made available to successful applicants. Award winner(s) will also be recognized at the annual awards banquet of the Dakota Chapter AFS and have their essay published in the AFS newsletter.

1. Robert L. Hanten Distinguished Professional Service Award

May be presented annually to no more than two individuals who have made an outstanding contribution within the field of fisheries. These contributions must have noteworthy significance within the two-state region and go beyond the requirements of a job description. Preferably all nominees should have been both Chapter and Parent Society members for at least eight years of their respective careers.

2. Aquatic Resource Conservation Award

May be presented annually to one individual or group that has made an outstanding effort in ensuring the future welfare of the Dakota's waters and/or fisheries. These efforts include but are not limited to: information, education, providing monetary or voluntary assistance, and legislative initiatives.

3. Outstanding Young Professional Award

May be presented annually to up to two individuals who have made outstanding contributions to the fisheries profession during the start of their fisheries careers. Nominees must not have completed five years of full-time fisheries employment. Contributions must be substantial and go beyond that required by their position. Nominees will have become established as contributors to the improvement of aquatic resources in North and South Dakota.

3. Best Paper Award


May be presented annually to recognize the best paper delivered at the annual meeting by a working professional.

Dakota Chapter Photography Contest Rules

- 1. This contest is open to all Dakota Chapter members including student members of the SDSU subunit (except contest judging committee).
- 2. Photos should have been taken within the last five years, and should be in focus and well-exposed. No digital artifacting (e.g. banding, colorshifts, pixilation, etc.) Digital images are encouraged; however film-based photos will be accepted.
- 3. To facilitate judging photos <u>must be submitted as unmated prints</u> sized 8"x10". Submissions of digital prints must also include a windows-based file of the print via CD or email (.jpg or .tif).
- 4. Digital images will be judged <u>based on the print</u>, <u>not the file</u> (i.e. pay attention to cropping, the quality of the printer, and photo paper used).
- 5. Categories will include: Angling, humor, kids & fishing, fieldwork, scenery, just fish, outdoor activities, wildlife, and other (good photo but doesn't fit a category).
- 6. Eight entries (photos) per chapter member will be allowed, but a single chapter member can only win a maximum of 1 category and "Best of Show".
- 7. Submitted photos will become property of the Dakota Chapter and may be used in future websites, presentations, and/or publications. Therefore, additional non-judged digital image files may be sent to add to the archives (indicate as non-judged photo).

All entries must be received by <u>Feb 7, 2013</u>, but the earlier the <u>better</u>. The Dakota Chapter of the American Fisheries Society is sponsoring a continuing education workshop entitled "Enhancing Scientific Communication" in conjunction with the 2014 Annual meeting. The workshop is organized around topics in the 2012 publication -- "Scientific Communication for Natural Resource Professionals" by C.A. Jennings, T.E. Lauer, and B. Vondracek, editors. The workshop will provide 'how to' guidance and approaches for improving both verbal and written communication skills.

Topics will include advice on (1) effective poster/oral presentations, (2) searching for and archiving scientific information, (3) style, usage & grammar for scientific reports, (4) guidance for manuscript preparation, (5) responding to peer reviews and criticism, (6) essentials of reviewing scientific papers and (7) professional communications: written comments, e-mails, memos and responses to the public.
